COMMISSION ON ACCREDITATION FOR LAW ENFORCEMENT AGENCIES PUBLIC COMMENT NOTIFICATION

Burbank, California – Since 2014, the Burbank Police Department has been recognized as an accredited law enforcement agency by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA®). Achieving and maintaining this accreditation requires voluntary compliance with approximately 400 applicable law enforcement standards established by CALEA® based on best practices within the field.

The Burbank Police Department is pursuing reaccreditation and is scheduled to participate in an upcoming virtual assessment.
