Meet Burbank's Newest Community Resource Officers

The Burbank Police Department recently appointed two new Community Resource Officers - Officer Rashaad Coleman and Officer Karissa Peltier. Community Resource Officers work as liaisons between citizens and the Police Department in helping to resolve community issues and reinforce community policing strategies and philosophies.

Burbank Police deploy two full-time Community Resource Officers, whose responsibilities include: recruitment, managing the Police Explorer program, special projects on matters of community relations and partnerships, investigating and addressing quality of life issues, serving as a referral source for citizens who are in need of special services, developing neighborhood watch groups and coordinating meetings, hosting the Community and Youth Academies, providing safety education in our local schools, and developing crime prevention strategies with local residents and businesses.

The Community Resource Officers also plan and host numerous community events throughout the year, including National Night Out, Shop With a Cop, Coffee With a Cop, Police and Fire Service Day, Drug Take Back, and more! They also serve as points of contact in coordinating local charitable events with organizations like the Special Olympics, American Red Cross, and Burbank Police Foundation.

Officer Peltier joined the Burbank Police Department in 2015, while Officer Coleman started his law enforcement career in 2016. Both were previously assigned to the Patrol Division before being named Community Resource Officers.

WHAT IS THE CENSUS?

The census is a count of every person who lives in the United States and its territories. It happens every 10 years. In early 2020, you will be asked to count everyone who lives in your home as of April 1. Responding to the 2020 Census is a chance to shape your future.

WHAT'S IN IT FOR ME?



Your responses inform where over \$675 billion is distributed each year to communities nationwide for clinics, schools, roads, and more.



Census data gives community leaders vital information to make decisions about building community centers, opening businesses, and planning for the future.



Responding also fulfills your civic duty because it's mandated by the U.S. Constitution. The United States has counted its population every 10 years since 1790.



Your responses are used to redraw legislative districts and determine the number of seats your state has in the U.S. House of Representatives.

IS MY INFORMATION SAFE?

Your responses to the 2020 Census are safe, secure, and protected by federal law. Your answers can only be used to produce statistics. They cannot be used against you by any government agency or court in any way—not by the FBI, not by the CIA, not by the DHS, and not by ICE.

WHEN CAN I RESPOND TO THE CENSUS?

In early 2020, every household in America will receive a notice to complete the census online, by phone, or by mail. In May, the U.S. Census Bureau will begin following up in person with households that have yet to respond.

WHAT WILL I BE ASKED?

You will be asked a few simple questions, like age, sex, and the number of people who live in your home, including children.

WHAT WON'T BE ASKED?

The census will never ask for Social Security numbers, bank or credit card numbers, money or donations, or anything related to political parties.

BEWARE: TAX SEASON SCAMS



As we all prepare for tax time, the Burbank Police Department would like to remind our community about scammers claiming to be from the I.R.S. demanding money from you.

Common phone, text message & e-mail scams:

- Individuals aggressively target taxpayers and may use threats of arrest or seizure of your property and assets. Some calls have even threatened a "lawsuit" against the taxpayer.
- Perpetrators will claim to be employees of the I.R.S., but they are not.
- They may use false names and fake I.R.S. ID or badge numbers to deceive you, and might mask or "spoof" their phone number, making the call appear authentic.
- Victims are often told they owe money to the I.R.S., which must be paid immediately through a prepaid debit card, gift card, or wire transfer.
- Victims might even be told they have a refund due in order to persuade them into providing personal and/or financial account information.

Remember, the I.R.S. will NEVER:

- Call you by phone and demand immediate payment. You will always receive an official written correspondence from the I.R.S.
- Have you utilize a prepaid debit card, gift card, or wire transfer for payment.
- Ask you for a debit or credit card number, or any other personal or financial information over the phone.
- Threaten you with incarceration or other law enforcement action.

If you receive these calls, text messages or emails, do not respond and call the I.R.S. directly at (800) 829-1040. If you have fallen victim to one of these scams, go to www.tigta.gov and fill out the "IRS Impersonation Scam" form. You should also report the incoming phone number on the Federal Trade Commission "Do Not Call" registry complaint website: complaints.donotcall.gov.
