Law Enforcement Officers, or their agency, shall immediately notify the local sexual assault victim counseling center whenever a victim is transported to a hospital for examination and the victim approves of that notification.

Following a sexual assault, a victim may contact the Crimes Against Person Detail at (818) 238-3210 to provide additional information, have questions answered, or track the progress of their case.

Sexual assault by a person who is known to the victim, including sexual assault by a person who is the spouse of the victim, is a crime.

Sexual assault victims will not incur out-of-pocket expenses for forensic medical exams (42 USC §3796gg; Penal Code §13823.95(a)).

No victim of sexual assault shall be required to participate or agree to participate in the criminal justice system, either prior to examination or at any other time (Penal Code §13823.95(b)).

### Information for Victim's of Domestic Violence

The San Fernando Valley Neighborhood Legal Services Clinic provides assistance in obtaining restraining orders, **(818) 896-5211 x106**. For information about the California victim's compensation program, you may contact **1-800-777-9229**.

Domestic Violence is criminal conduct. As the victim of domestic violence, you may ask the District Attorney to consider filing a criminal complaint. Additionally, you have the right to file a petition with the Superior Court requesting any of the following orders for relief:

- A. An order restraining the attacker from abusing the victim and other family members.
- B. An order directing the attacker to leave the household.
- C. An order preventing the attacker from entering the residence, school, business or place of employment of the victim.
- D. An order awarding the victim or the other parent custody of or visitation with a minor child or children.
- E. An order restraining the attacker from molesting or interfering with minor children in the custody of the victim.
- F. An order directing the party not granted custody to pay support of minor children if that party has a legal obligation to do so.
- G. An order directing the defendant to make specified debit payments coming due while the order is in effect.
- H. An order directing that either or both parties participate in counseling.

Domestic violence or assault by a person who is known to the victim, including domestic violence or assault by a person who is the spouse of the victim, is a crime.

As a victim of domestic violence, you have the right to file a civil suit for losses suffered as a result of abuse or injuries sustained, including medical expenses, loss of earnings, damage to property and other related expenses incurred by the victim or any agency that shelters the victim.
