Remembering Burbank Police Officer Matthew Pavelka, End of Watch, November 15, 2003





November 15 will mark the anniversary of BPD Fallen Officer Matthew Pavelka. Matthew Pavelka was appointed as a police officer for the City of Burbank on August 5, 2002.

On the evening of November 15, 2003, Officer Gregory Campbell stopped to investigate a vehicle without license plates, occupied by two males, parked in an area known for drug trafficking and other criminal activity. Officer Campbell wisely called for backup.

The first officer to respond was 26-year-old Matthew Pavelka, who had been in the field as a police officer for just ten months. When Officer Campbell and Officer Pavelka approached the suspect's vehicle, the two occupants exited, both armed with guns. The suspects then fired at the officers. Both Officer Campbell and Officer Pavelka were wounded, but in the ensuing exchange of gunfire, the officers shot and killed one of the gunmen. The other suspect escaped on foot.

Both of the wounded officers were transported to a local hospital, where Officer Pavelka succumbed to his injuries. Officer Campbell was treated and remained in critical but stable condition.

On Thanksgiving Day, November 27, 2003, the suspect who fled was taken into custody.

Remembering Burbank Deputy City Marshal Luther Colson, End of Watch, November 16, 1914





November 16 will mark the anniversary of BPD Fallen Deputy City Marshal Luther Colson. Luther Colson was appointed as a City Marshal for the City of Burbank on February 21, 1914.

Marshal Colson was on duty on November 16, 1914, at about 7:00 p.m., when he was walking along the railroad tracks in the area of Lake Street and Victory Boulevard. Suddenly, several suspects began shooting at him from the nearby brush. One bullet struck Marshal Colson in the stomach. He returned fire, and after several shots, the suspects fled into the darkness. Marshal Colson started to return to town but collapsed. Citizens transported him to Burbank Hospital for treatment, but he succumbed to his injuries.

The Marshal of Tropico (a small community located at Los Feliz and San Fernando Boulevard, now part of Glendale), with twenty-five deputies, immediately started a search for the suspects. On November 18, 1914, three suspects were apprehended. One suspect had a gun matching the same caliber that was used in wounding of Marshal Colson. After a lengthy interrogation, all three suspects confessed to their involvement in the shooting.


