BURGLARY SUSPECTS ARRESTED

DATE: May 29, 2014

Burbank residents experienced a recent rash of daytime residential burglaries. There have been ten reports in the past two weeks where the suspects entered by cutting screens to access unlocked windows and doors to steal jewelry, cash, and other concealable items.

On Wednesday, May 28, 2014, at approximately 1:50 p.m., Burbank Police officers responded to the 400 block of North Catalina regarding a residential burglary report that occurred in the last hour. While at the scene, officers received an additional call of a residential burglary alarm in the 400 block of North Buena Vista.

Investigative personnel identified a suspicious vehicle in the area and requested assistance from patrol officers to make a traffic stop which ultimately led to the arrest of two suspects. Property from the North Catalina burglary was recovered from the vehicle and identified by the homeowners.

Terry Jones, M/24 and Marc Smith, M/21 from Los Angeles were both arrested for 459 PC-residential burglary. They were booked into the Burbank Jail and are due in court on Friday, May 30, 2014. Bail is set at \$50,000.

The investigation is ongoing and detective personnel are attempting to identify additional property recovered to return it to the rightful owners.
